

PRIVACY POLICY

This Privacy Policy is incorporated by reference into the Launch Wellness Co-Working Space Membership Agreement and Terms of Use ("Membership Agreement") and the Launch Wellness "Austin Launch" Associate Agreement ("Austin Launch Associate Membership Agreement"). The terms "Launch Wellness," "we," and "us" include Launch Wellness, LLC and our affiliates and subsidiaries. The Privacy Policy explains how Launch Wellness may: (1) collect, (2) use, and (3) disclose information we obtain by providing the Launch Wellness Services and Premises (as those terms are defined in the Membership Agreement and the Austin Launch Associate Membership Agreement) or through the Launch Wellness website ("Launch Wellness Site").

"Personal Information" means information that alone or when in combination with other information may be used to readily identify, contact, or locate you, such as: name, address, email address, or phone number. We do not consider Personal Information to include information that has been anonymized so that it does not allow a third party to easily identify a specific individual.

Launch Wellness Collects Your Information:

Launch Wellness collects Personal Information when you:

- create an account;
- apply for a membership to use our co-working premises and services;
- apply for an associate membership;
- post or provide information to Launch Wellness that includes Personal Information; and
- communicate with us.

We also collect information, such as anonymous usage statistics, by using cookies, server logs, and other similar technology as you use the Launch Wellness Site.

Registration. To create a membership account, you may need to provide Personal Information, such as your name, email address, address and provide your credit card number and billing address. Launch Wellness agrees that it will only use a Payment Card Industry Data Security Standard (PCI-DSS) certified payment processor to store your credit information.

Using the Launch Wellness Site. We may collect the Personal Information you post as you use the Launch Wellness Site, such as when you apply for membership to use the Launch Wellness Service, or post your comments in a chat room or on a blog post. We discourage posting sensitive or Personal Information in comments as they are viewable by the public.

Social Log-In. When you use your social media credentials to apply for membership or to post a comment to the Launch Wellness Site, we collect Personal Information from the social media website. For example, when you log in with your Facebook credentials, we may collect the Personal Information you have made publicly available in Facebook, such as your name and profile picture or logo. We may also collect your email address.

From Third Parties. We may use third parties to perform certain tasks for us, such as facilitating your purchase of a membership. Such third parties will provide us the Personal Information, such as your name, address, and email address, you provide to them.

Making Payments. When you make payments to pay for a membership, you may need to provide Personal Information to our third-party service providers, such as your credit card number.

Cookies, Automatic Data Collection, and Related Technologies. The Launch Wellness Site collects and stores information that is generated automatically as you use it, including your preferences and anonymous usage statistics. For example, we will also use your IP address to determine your physical location when you log in so we can personalize the Service for you. You may change your location information in your account settings. When you visit the Launch Wellness Site, we and our third-party service providers receive and record information on our server logs, including your IP address, and from cookies and similar technology. Cookies are small text files placed in visitors' computer to store their preferences. You can use your browser to block and delete cookies from your browser. However, if you do that, the Launch Wellness Site may not work properly. By using the Launch

Wellness Site, you are authorizing us to gather, parse, and retain data related to the provision of the Launch Wellness Site.

How Launch Wellness Uses Your Information

We use Personal Information to provide and improve our services; and to communicate with you.

Internal and Service-Related Usage. We use information, including Personal Information, for internal and service-related purposes and may provide it to third parties to allow us to facilitate the Launch Wellness Site. We may use and retain any data we collect to provide and improve our services.

Communications. We may send email to the email address you provide to us to verify your account and for informational and operational purposes, such as account management, customer service, or system maintenance.

Marketing. We do not rent, sell, or share Personal Information about you with other people or nonaffiliated companies for their direct marketing purposes. We may use your Personal Information to facilitate transmittal of information that may be useful, relevant, valuable or otherwise of interest to you.

Aggregate Data. We may anonymize and aggregate data collected through the Launch Wellness Site and use it for any purpose.

Launch Wellness May Disclose Your Information.

We may share your information:

- with our third-party service providers;
- on the Launch Wellness Site;
- with social networking websites, at your direction;
- to comply with legal obligations;
- to protect and defend our rights and property; and
- with your permission.

We Use Vendors and Service Providers. We may share any information we receive with vendors and service providers retained in connection with the provision of the Launch Wellness Site. These service providers may have their own privacy policies.

Displaying to Other Users. Some content you post to the Launch Wellness Site may be displayed on the Launch Wellness Site. Other users of the Launch Wellness Site may be able to see some information about you, such as information contained in comments posted in a chat room or on a blog post.

Social Networking and Other Websites. The Launch Wellness Site may allow you to post information to social networking websites. We do not share your information with them unless you direct Launch Wellness to share it. Their use of the information will be governed by their privacy policies, and we do not control their use of the shared data.

As Required By Law and Similar Disclosures. We may access, preserve, and disclose your Personal Information, other account information, and content if we believe doing so is required or appropriate to: comply with law enforcement requests and legal process, such as a court order or subpoena; respond to your requests; or protect yours, ours or others' rights, property, or safety.

Merger, Sale, or Other Asset Transfers. If we are involved in a merger, acquisition, financing due diligence, reorganization, bankruptcy, receivership, sale of company assets, or transition of service to another provider, your information may be sold or transferred as part of such a transaction as permitted by law and/or contract. We cannot control how such entities may use or disclose such information.

We may also disclose your Personal Information with your permission.

Security Of Your Information

We take steps to ensure that your information is treated securely and in accordance with this Privacy Policy. Unfortunately, the Internet cannot be guaranteed to be 100% secure, and we cannot ensure or warrant the security of any information you provide

to us. By using the Launch Wellness Site or providing Personal Information to us, you agree that we may communicate with you electronically regarding security, privacy, and administrative issues relating to your use of the Launch Wellness Site. If we learn of a security system's breach, we may attempt to notify you electronically by posting a notice on the Launch Wellness Site or sending an email to you. You may have a legal right to receive this notice in writing. To receive free written notice of a security breach (or to withdraw your consent from receiving electronic notice), please notify us at launchwellnessaustin@gmail.com

Children's Privacy

We do not knowingly collect, maintain, or use Personal Information from children under 13 years of age, and no part of the Launch Wellness Site is directed to children under the age of 13. If we learn that we have collected any Personal Information from children under 13, we will promptly take steps to delete such information and terminate the child's account.
